# **OVERVIEW**

**Appropriations** season began in Q2 2022, ensuring a busy quarter for Commonwealth **Strategic Partners** (CSP). We were energized, however, by the announcement in May that CSP was named among Bloomberg Government's Top Performing Lobbying Firms of 2021. You can read our press release on the announcement here.

# LEGISLATIVE ADVOCACY

### **The City of Aberdeen Station Square Project**

CSP worked with client the <u>City of Aberdeen</u>, <u>MD</u> during the appropriations process. Senators Chris Van Hollen (D-MD) and Ben Cardin (D-MD), and Representative Dutch Ruppersberger (D-MD-02) all selected Aberdeen's Station Square improvements project as one of their Appropriations requests for community project funding. In June, Rep.

Ruppersberger was successful in securing Aberdeen's project in the House Transportation Appropriations bill as a \$4 million Federal Transit Administration (FTA) project. The bill successfully passed in committee and the full House.

In April, Aberdeen applied for a Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant. The application had the support of both Maryland Senators and seven MD Members of the House of Representatives. The delegation expressed their support in a letter to Department of Transportation Secretary Pete Buttigieg.

### **EB-5 Regional Center Program**

In June, on behalf of client <u>Invest in the USA</u> (IIUSA), CSP worked with Representatives Dwight Evans (D-PA-03), Brian Fitzpatrick (R-PA-01), and Tom O'Halloran (D-AZ-01) to send a letter to the U.S. Citizenship & Immigration Services (USCIS) urging it to reconsider its stance that all previously designated EB-5 Regional Centers must redesignate under the Reform and Integrity Act of 2022 (RIA).

In May, Senators Chuck Schumer (D-NY), Lindsay Graham (R-SC), and John Cornyn (R-TX) and Representative Jerry Nadler (D-NY), sent a similar letter to Department of Homeland Security Secretary Alejandro

Mayorkas urging the Secretary to not require Regional Centers to redesignate.

## **CISA Cybersecurity Advisory Committee**

In April, on behalf of client the National Technology Security Coalition (NTSC), CSP worked with Representative John Katko (R-NY-24) to send a letter to the Cybersecurity and Infrastructure Security Agency (CISA) director Jen Easterly regarding the membership of the CISA Cybersecurity Advisory Committee (CSAC). The letter encourages Director Easterly to consider including more chief information security officers in the remaining open committee seats. CSAC was championed in 2019 by Rep. Katko and the NTSC. Its mission is to convene a group of experts from industry and academia who can advise CISA on cybersecurity issues. It had its first meeting in December 2021.

### **Landline**

In June, CSP client Landline announced their partnership with American Airlines, bringing new travel options to Pennsylvania and New Jersey. Landline now offers service at Lehigh Valley International Airport and Atlantic City International Airport with seamless connections through Philadelphia International Airport to American Airlines' global network. Throughout the quarter, CSP and Landline met with the Congressional delegations representing these airports and Congressional committees with jurisdiction over legislative issues of importance to Landline.

On May 17, Senators Marco Rubio (R-FL) and Jon Ossoff (D-GA) and Representatives John Rutherford (R-FL), Al Lawson (D-FL), and John Katko (R-NY) held a press conference on their bill, the Homes for Every Local Protector, Educator, and Responder (HELPER) Act, which CSP has championed since its inception. The lawmakers were joined by representatives from supporting organizations including the DC FOP Capitol Police Labor Committee, the Peace Officers Research Association of California, and the District of Columbia Firefighters Association. Event attendees heard from leaders throughout the industry on a host of the industry's most important topics as well as a keynote speaker from the Hall of Fame Resort, who detailed the success of EB-5 in their redevelopment efforts.
