OVERVIEW

The 118th Congress began in January 2023. In the wake of the retirement of several key Congressional allies, [Commonwealth Strategic Partners](#) (CSP) worked to find new champions for our clients' issues. Additionally, the new Congress brought with it 82 new members, so CSP worked to introduce our clients to those new members and reaffirm our relationships with members returning from the previous Congress.

LEGISLATIVE ADVOCACY

Aircraft Mechanics Fraternal Association

In February and March, CSP hosted client [Aircraft Mechanics Fraternal Association](#) (AMFA) in D.C. for 16 meetings with staff for members who serve on the House Aviation Subcommittee. The purpose of the meetings was to educate members on AMFA's labor and safety priorities for the upcoming Federal Aviation Administration reauthorization bill that is expected to be introduced this year.

Additionally, CSP worked with AMFA to endorse the [Global Aircraft Maintenance Safety Improvement Act](#) introduced by Reps. Marc Molinaro (R-NY) and Julia Brownley (D-CA) and the [Aviation Workforce Development Act](#) introduced by Rep. Mike Collins (R-GA).



Granite Construction

In March, CSP hosted client [Granite Construction](#) in D.C. for meetings with 17 Congressional offices including meeting personally with Reps. Ken Calvert (R-CA), John Garamendi (D-CA), Dan Newhouse (R-WA), Lance Gooden (R-TX), Maria Gluesenkamp Perez (D-WA), Jimmy Panetta (D-CA), John Carter (R-TX), and James Moylan (R-GU). Granite advocated for efficiencies in the military contracting process, transportation funding, and for Department of Energy funding for upgrades to their asphalt plants to reduce their carbon footprint.

Invest in the USA

In February, CSP hosted client [Invest in the USA](#) (IIUSA) in D.C. for the first of many lobby days planned for 2023. CSP and IIUSA board members met with staff from 16 Congressional offices. The goals of the meetings were to introduce new members of Congress to IIUSA and the EB-5 Regional Center Program and to reconnect with offices familiar with the issue to discuss legislative strategies to preserve and improve the program.



Lendmark Financial Services

CSP and Lendmark met in-person with staff from ten Congressional offices and met personally with Rep.
